- Ceramics (Stoneware, clay and porcelain)
- Photography (Film and digital)
- Mixed Media (Collage, fiber art, printmaking, digital/graphic art) *contact us for AI generated

- Jewelry (Lamp work, metal work, fused glass, clay polymer, pyrite, ceramic jewelry, carved wood, stone)* all jewelry must be at least 85% artist created/worked material

Important Dates

Friday, September 30 (Entry deadline): All entries must be received either electronically or via postal mail. Any work submitted after this date will not be accepted.

Tuesday, October 11 (Notification of Acceptance): Notification of acceptance will be sent via email. **Sunday, October 16, 10am-5:00 pm (Art Drop Off)**: Drop off work from 10 am to 5:00 pm at the Dulles State Office Building, 317 Washington Street, Watertown, NY.

Friday, October 28, 5pm-7pm: Opening and Awards Ceremony. If at all possible, please plan to attend. After party immediately following awards (location TBD)

Sunday, November 20, 10am-3pm (Art Pick Up): All work must be picked up. We cannot be responsible for work that is not picked up. **The NCAC is not responsible for any work not picked up.** Please send a representative if you are unable to make the pickup yourself.

Entry Fees

NCAC Members: \$35 for the first entry, \$5 for each additional entry **Non-Members**: \$40 for the first entry, \$5 for each additional entry Maximum of five entries per artist ~ **Fees are non-refundable**

Entry Details

- 1. All submissions must include images (.jpg, .png) of the work being submitted.
- 2. Each entry must be accompanied by a completed application form for each piece.
- Payment of entry fees must be paid at time of submission before they are judged for admission.
- 4. All submissions must include an artist statement/biography.
- 5. At least 50% of the work submitted to the Fall Art Show must be priced for sale.

Submitting Work
